Regular Meeting Minutes Wednesday January 24, 2018

Senator Stewart moved to "adopt the agenda as presented." Motion passed without objection.

Senator Stewart moved to, "approve the minutes from the January 10, 2018 meeting as presented." Motion passed without objection.

### REPORTS

Treasurer Tervalon provided an update on the ASCOA budget and provided the board with recommendations to avoid overspending the budget.

Treasurer Tervalon moved to approve, "payment of the ACUI membership fee [\$836.00] from fund 81." Motion approved without objection.

Treasurer Tervalon moved to "postpone nominations for ASCOA secretary until March." Motion approved without objection.

The following senators were nominated to serve as the secondary delegate: Bryant Montufar (accepted), Clemaus Tervalon (not accepted) and Lalia Domingo (accepted). Senator Montufar was selected as the secondary delegate.

Treasurer Tervalon moved to create an ad hoc committee of three senators to identify and recommend a list of possible team building activities.
