




## **Enrollment Trends**

Collegewide the enrollment trend has been fairly consistent over the last three years. Three years ago (26,255) is consistent with last year's numbers (27,948) and 2 years ago (29.148) the college had a higher level of enrollment, this trend is very similar that of the Counseling Department's enrollment number over the last 3 years (524, 652, 522). Productivity (2016-17: 15.32, 2017-18: 14.88, and 2018-19: 14.57) has decreased collegewide over the course of the past 3 years, whereas the Counseling Departments' productivity (2016-17: 15.39, 2017-18: 16.11, and 2018-19: 16.88) has increased over the last 3 years.

#### Describe effective and innovative teaching strategies used by faculty to increase student learning and engagement.

The Counseling Department teaches courses related to college success (e.g., high-performance learning utilizing information organization and management, critical thinking and problem-solving skills, effective time management learning styles, memory theory, goal setting, and educational planning), career life planning (e.g., self-exploration, identifying values, interests, needs and goals: over the life span, influence of career choice on the quality of life, development of a career action plan) just to name a few. Additionally, the Counseling Department is focusing on Career Exploration techniques by including the Super Strong Personality Assessment prior to counseling sessions. Also, the Counseling Department is involved with the Guided Pathways model and framework to guide the Counseling process with regards to providing educational mapping tools for students so they can more easily select courses.

#### How is technology used by the discipline, department?

Counselors use a variety of applications to deliver materials - for example, career applications and websites, YouTube videos, career assessment websites. Counselors use Canvas to teach counseling courses and will also be using Zoom to engage in online counseling meetings.

The department has representation on the DE committee. Instructors are encouraged to continue to develop their online teaching skills through professional development opportunities.

Counseling Department Chairs have worked with SLO Coordinator over the last 3 years to discuss, plan, and evaluate counseling courses. The Counseling Department has worked collaboratively on course offerings and by providing a rotation of courses and professor offerings. Additionally, at one time a task force was formed to evaluate counseling courses. The plan for the Spring 2020 semester is to form a task force again to evaluate counseling courses and discuss planning strategies. The Counseling Department Chairs evaluate data and discuss collaboration activities and ideas regularly.

The Department has learned that student's productivity has increased by offering online courses as per the data has shown over the last 3 years (2016-17: 15.39, 2017-18: 16.11, and 2018-19: 16.88).




