- 3. Catalog update Frank Nguyen Le

There is a catalog timeline. Please work with originiating faculty or dept chairs to update courses that need catalog changes. This get approved at the local curriculum committee, then the district CIPD, then board of trustees approval, then state approval and last changed in catalog.

As a multi college district, we use a uniform course numbering system. Thus, we have to have consultation done within the department at the college and districtwide. This includes courses that we're trying to clone and new courses that we might try to bring on board. In program review, there's a section asks about course outlines and textbooks are up to date. This is important even if it's a non-catalog change. Consultation is also a collaborative effort where people in CoA and outside of the campus can bring their minds together.

- 5. VPI Updates Dr. Diana Bajrami
 - a. Winter Intersession

Has been finalized and the deans have contacted you already. Intersessions aren't part of the load; faculty can teach max of 2 courses and students can take a max of 2 courses; students may receive some special waiver to take more than 2 students. Holidays can't be teaching days; the maximum units per course to be taught is 3 units. Sometimes it's hard to find faculty to teach intersession; perhaps it's a good idea to expand pool of PT faculty. If there's an emergency hire, there's a general pool that people can apply; we need to allow time for epafs to generate. There is a part of the dept chair website with resources on hiring new faculty. Louie to get the schedule and place in the Microsoft Teams

b. Dual Enrollment Planning Spring 2022

How can we have class notes on the schedule appear uniform for students to understand better? We have some recommendations from the CA Academic Senate that has passed resolutions on the language.

The goal is to decrease cancellations. It seems like the cap will go back to 40 students. Faculty may be contacted in January between semesters.

The chair is a gatekeeper between VPI/Deans office and faculty. CoA is doing poorly in dual enrollment compared to sister colleges. It's a great resource for us to generate FTES and increase enrollment. It's a moral imperative to reach out to high schools and provide resources. We need to do mapping of our own on what we might need to connect with student services with enrollment. Dual enrollment is not part of FTEF; it's extra.

Dual Enrollment is the responsibility of the VPI and Instructional Deans. Concurrent versus Dual Enrollment by VPI Bajrami; Concurrent enrollment (not the same as dual enrollment) = high school students taking classes at COA or other colleges per Anthony Villegas
