Title 5 Updates to AP 4105	The District DE Committee is requesting local campus DE Committees provide feedback about updating AP 4105 to align with new changes to Title 5. Some of the changes involve legal language that cannot be changed, but there is a request to provide feedback on the Faculty Selection. Feedback on Faculty Selection: Make training opportunities accessible and flexible for faculty, especially adjunct faculty. Leave room for faculty to complete homegrown trainings within PCCD or provide documentation of equivalent training outside the district. Focus on both online teaching pedagogy and learning management system training. Suggest ongoing training—not require it. Clarify that faculty verify successful completion of trainings or active enrollment in one. The latter is helpful for last minute hires and granting flexibility.
