- Meeting called to order at 1:18 PM
- A motion was made to approve the agenda for today, the motion passes
- A motion was made to approve the minutes for the meeting on November 22nd, the motion passes
- After some discussion, it was decided that the best time to hold the Holiday Rest Stop event is on December 12th, after Tasty Tuesday
- The point of the event is for the students to relax and possibly get some studying in before their finals
- There can be holiday music in the background, board games, a Christmas Tree, and

there is the possibility of bringing dogs that the students can relax with during the event

- Jay takes up the offer of creating a flier for the event, which should preferably be made by Monday the 4th, or Tuesday the 5th
- In order to have snacks for the event, the board needs to create a food memo
- Natalie passes out a printout of the budget to help the board members decide the food memo
- A motion was made to create a food memo of \$10,000 for this year by moving \$7,000 from Fund 4999 (Unallocated Budget) to Fund 5106 (Events/Programs-Outside Prod) - the motion passes
- After further discussion of the event, it is decided that small snacks were best such as chips, cookies, granola bars, etc and that catering should be saved for bigger events such as Welcome Week
- An estimate of ~150 people for this event
- If a board member wanted to buy snacks on their own and be reimbursed, they cannot spend more than \$100
- A motion was made to set a budget of \$1,000 for this event, the motion passes
- A motion was made to move the fridge from the old meeting room to the first floor of the F building, the fridge can serve as a "grab-n-go" station for students with food insecurity, the motion passes

- It was recently found out that the board members have a bill of \$6,454.95 due to late fees and usage owed to a copier, a motion was made to use \$6,500 from fund 4999 to pay off that bill, the motion passes
- Natay has expressed interest in helping out the Toy Drive happening on December 12th, further discussion will be added to the agenda for next meeting
