Fowler shared that CoA's Participatory Governance Handbook is outdated and was last updated in 2019-2020. She posed a question about how this project should be tackled. A suggestion was made about creating a subcommittee or task group. After discussion, President Dixon made proposal to form a body to take on the charge of reviewing the handbook and put forth recommendations that would go in front of governance committees and for broader campus wide feedback.
